- 2 (a) Remote pharmacy services using automated pharmacy systems.
- 3 (1) Purpose. The purpose of this section is to provide standards for the provision of pharmacy
- 4 services by a Class A or Class C pharmacy in a facility that is not at the same location as the
- 5 Class A or Class C pharmacy through an automated pharmacy system as outlined in §562.109 of
- 6 the Texas Pharmacy Act.

- which remote pharmacy services are provided using an automated pharmacy dispensing system.
- 14 (C) Prepackaging--The act of repackaging and relabeling quantities of drug products from a
- manufacturer's original commercial container, or quantities of unit dosed drugs, into another
- cartridge or container for dispensing by a pharmacist using an automated pharmacy system.
- 17 (D) Provider pharmacy--The community pharmacy (Class A) or the institutional pharmacy
- 18 (Class C) providing remote pharmacy services.
- 19 (E) Remote pharmacy service--The provision of pharmacy services, including the storage and
- 20 dispensing of prescription drugs, in remote sites.
- 21 (F) Unit dose--An amount of a drug packaged in a dosage form ready for administration to a
- 22 particular patient, by the prescribed route at the prescribed time, and properly labeled with name,
- strength, and expiration date of the drug.
- 24 (3) General requirements.
- 25 (A) A provider pharmacy may provide remote pharmacy services using an automated pharmacy
- system to a jail or prison operated by or for the State of Texas, a jail or prison operated by local
- 27 government or a healthcare facility regulated under Chapter 142, 242, 247, or 252, Health and
- Safety Code, provided drugs are administered by a licensed healthcare professional working in
- 29 the jail, prison, or healthcare facility.
- 30 (B) A provider pharmacy may only provide remote pharmacy services using an automated
- 31 pharmacy system to inpatients of the remote site.
- 32 (C) A provider pharmacy may provide remote pharmacy services at more than one remote site.

- comply with the provisions of §§291.31 291.34 of this title (relating to Definitions, Personnel,

- 39 (F) The pharmacist-in-charge of the provider pharmacy is responsible for all pharmacy
- 40 operations involving the automated pharmacy system located at the remote site including
- supervision of the automated pharmacy system and compliance with this section.
- 42 (G) A pharmacist from the provider pharmacy shall be accessible at all times to respond to
- patient's or other health professionals' questions and needs pertaining to drugs dispensed through
- 44 the use of the automated pharmacy system. Such access may be through a 24 hour pager service
- or telephone which is answered 24 hours a day.
- 46 (4) Operational standards.
- 47 (A) Application for permission to provide pharmacy services using an automated pharmacy
- 48 system.
- 49 (i) A Class A or Class C Pharmacy shall <u>file a completed application containing all information</u>
- 50 <u>required by [make application to]</u> the board to provide remote pharmacy services using an
- 51 automated pharmacy system. [The application shall contain an affidavit with the notarized
- 52 signatures of the pharmacist-in-charge, and the medical director or the person responsible for the

- 73 (i) A provider pharmacy shall notify the board in writing within ten days of a [change of

- 75 (I) a remote site where an automated pharmacy system is operated by the pharmacy; or
- 76 (II) a remote pharmacy service at a remote site.
- 77 (ii) A provider pharmacy shall comply with appropriate federal and state controlled substance
- 78 registrations for each remote site if controlled substances are maintained within an automated
- 79 pharmacy system at the facility.
- 80 (iii) A provider pharmacy shall file a change of location and/or name of a remote site as specified
- 81 <u>in §291.3 (relating to Notifications) of this title.</u>
- 82 (C) Environment/Security.
- 83 (i) A provider pharmacy shall only store drugs at a remote site within an automated pharmacy
- 84 system which is locked by key, combination or other mechanical or electronic means so as to
- prohibit access by unauthorized personnel.
- 86 (ii) An automated pharmacy system shall be under the continuous supervision of a provider
- 87 pharmacy pharmacist. To qualify as continuous supervision, the pharmacist is not required to be
- physically present at the site of the automated pharmacy system if the system is supervised
- 89 electronically by a pharmacist.
- 90 (iii) Automated pharmacy systems shall have adequate security and procedures to:
- 91 (I) comply with federal and state laws and regulations; and
- 92 (II) maintain patient confidentiality.
- 93 (iv) Access to the automated pharmacy system shall be limited to pharmacists or personnel who:
- 94 (I) are designated in writing by the pharmacist-in-charge; and

- 95 (II) have completed documented training concerning their duties associated with the automated
- 96 pharmacy system.
- 97 (v) Drugs shall be stored in compliance with the provisions of §291.15 of this title (relating to
- 98 Storage of Drugs) and §291.33(f)(2) of this title including the requirements for temperature and
- 99 handling of outdated drugs.
- 100 (D) Prescription dispensing and delivery.
- 101 (i) Drugs shall only be dispensed at a remote site through an automated pharmacy system after
- receipt of an original prescription drug order by a pharmacist at the provider pharmacy in a
- manner authorized by §291.34(b) of this title.
- 104 (ii) A pharmacist at the provider pharmacy shall control all operations of the automated
- pharmacy system and approve the release of the initial dose of a prescription drug order.

- 158 (IV) date of last review/revision of the policy and procedure manual; and

- 160 (-a-) security;
- (-b-) operation of the automated pharmacy system;
- 162 (-c-) preventative maintenance of the automated pharmacy system;
- 163 (-d-) sanitation;
- 164 (-e-) storage of drugs;
- 165 (-f-) dispensing;
- 166 (-g-) supervision;
- 167 (-h-) drug procurement;
- 168 (-i-) receiving of drugs;
- 169 (-j-) delivery of drugs; and
- 170 (-k-) recordkeeping.
- 171 (ii) A pharmacy that provides pharmacy services through an automated pharmacy system at a
- remote site shall, at least annually, review its written policies and procedures, revise them if
- necessary, and document the review.
- 174 (iii) A pharmacy providing remote pharmacy services using an automated pharmacy system shall
- maintain a written plan for recovery from an event which interrupts the ability of the automated
- pharmacy system to dispense prescription drugs. The written plan for recovery shall include:
- 177 (I) planning and preparation for maintaining pharmacy services when an automated pharmacy
- 178 system is experiencing downtime;

- (B) Prescriptions. Prescription drug orders shall meet the requirements of §291.34(b) of this title.
- 200 (C) Records of dispensing. Dispensing records for a prescription drug order shall be maintained
- by the provider pharmacy in the manner required by §291.34(d) or (e) of this title.
- 202 (D) Transaction information.
- 203 (i) The automated pharmacy system shall electronically record all transactions involving drugs
- stored in, removed, or dispensed from the system.
- 205 (ii) Records of dispensing from an automated pharmacy system for a patient shall be maintained
- by the providing pharmacy and include the:
- 207 (I) identity of the system accessed;

- 374 (G) Policies and procedures of operation.
- 375 (i) A provider pharmacy that provides pharmacy services through an emergency medication kit
- at a remote site shall operate according to written policies and procedures. The policy and
- procedure manual shall include, but not be limited to, the following:
- 378 (I) duties which may only be performed by a pharmacist;
- 379 (II) a copy of the written contract or agreement between the pharmacy and the facility which
- outlines the services to be provided and the responsibilities and accountabilities of each party in
- fulfilling the terms of the contract in compliance with federal and state laws and regulations;
- 382 (III) date of last review/revision of the policy and procedure manual; and
- 383 (IV) policies and procedures for:
- 384 (-a-) security;
- 385 (-b-) operation of the emergency medication kit;
- 386 (-c-) preventative maintenance of the automated pharmacy system if the emergency medication
- 387 kit is an automated pharmacy system;
- 388 (-d-) sanitation;
- 389 (-e-) storage of drugs;
- 390 (-f-) dispensing;
- 391 (-g-) supervision;
- 392 (-h-) drug procurement;
- 393 (-i-) receiving of drugs;
- 394 (-i-) delivery of drugs; and
- 395 (-k-) recordkeeping.
- 396 (ii) A pharmacy that provides pharmacy services through an emergency medication kit at a
- remote site shall, at least annually, review its written policies and procedures, revise them if
- 398 necessary, and document the review.

- 399 (iii) A pharmacy providing remote pharmacy services using an emergency medication kit which
- is an automated pharmacy system shall maintain a written plan for recovery from an event which
- interrupts the ability of the automated pharmacy system to provide emergency medications. The
- written plan for recovery shall include:
- 403 (I) planning and preparation for maintaining pharmacy services when an automated pharmacy
- 404 system is experiencing downtime;
- 405 (II) procedures for response when an automated pharmacy system is experiencing downtime; and

- 408 (A) Maintenance of records.

- 413 (II) supplied by the provider pharmacy within 72 hours, if requested by an authorized agent of

- 422 (C) Records of dispensing. Dispensing records for a prescription drug order shall be maintained
- by the provider pharmacy in the manner required by §291.34(d) or (e) of this title.
- 424 (D) Transaction information.
- 425 (i) A prescription drug order shall be maintained by the provider pharmacy as the record of
- removal of a drug from an emergency medication kit for administration to a patient.
- 427 (ii) The remote site shall notify the provider pharmacy electronically or in writing of each entry
- into an emergency medication kit. Such notification may be included on the prescription drug
- order or a separate document and shall include the name, strength, and quantity of the drug
- 430 removed, the time of removal, and the name of the person removing the drug.

- 431 (iii) A separate record of stocking, removal, or dispensing for administration from an emergency
- medication kit shall be maintained by the pharmacy and include the:

- 472 (B) Remote dispensing site-- a location licensed as a telepharmacy that is authorized by a

- devices, including dangerous drugs and controlled substances.
- 475 (C) Remote healthcare site-a healthcare facility regulated by this state or the United States that is
- 476 <u>a:</u>
- 477 (i) rural health clinic regulated under 42 U.S.C. Section 1395x(aa);
- 478 (ii) health center as defined by 42 U.S.C. Section 254b;
- 479 (iii) healthcare facility located in a medically underserved area as determined by the United
- 480 States Department of Health and Human Services; or
- 481 (iv) healthcare facility located in a health professional shortage area as determined by the United
- 482 States Department of Health and Human Services.
- 483 [(C) Remote site--a facility not located at the same location as a Class A or Class C pharmacy, at
- 484 which remote pharmacy services are provided using a telepharmacy dispensing system.]
- (D) Remote site--a remote healthcare site or a remote dispensing site.
- 486 (E) [(D)] Remote pharmacy service--The provision of pharmacy services, including the storage
- and dispensing of prescription drugs, drug regimen review, and patient counseling, at a remote
- 488 site.
- 489 (F) [(E)] Still image capture--A specific image captured electronically from a video or other
- 490 image capture device.
- 491 (G) [<del>F</del><del>-</del>| Store and forward--A video or still image record which is saved electronically for
- 492 future review.

- 493 (H) [(G)] Telepharmacy system--A system that monitors the dispensing of prescription drugs and
- 494 provides for related drug use review and patient counseling services by an electronic method
- which shall include the use of the following types of technology:
- 496 (i) audio and video;
- 497 (ii) still image capture; and
- 498 (iii) store and forward.
- 499 [(H) Unit of use A sufficient quantity of a drug for one normal course of therapy as determined

- 502 (A) A provider pharmacy may provide remote pharmacy services using a telepharmacy system at

- 514 (i) the census tract in which the remote site is located, if the remote site is located in a

- 760 (II) supplied by the provider pharmacy within 72 hours, if requested by an authorized agent of
- 761 the Texas State Board of Pharmacy. If the pharmacy maintains the records in an electronic
- format, the requested records must be provided in an electronic format if specifically requested
- by the board or its representative. Failure to provide the records set out in this section, either on

- 364 site or within 72 hours, constitutes prima facie evidence of failure to keep and maintain records
- 765 <u>in violation of the Act.</u>
- 766 (ii) The provider pharmacy shall maintain original prescription drug orders for medications
- dispensed from a remote site using a telepharmacy system in the manner required by §291.34(b)
- of this title.
- 769 (iii) If prescription drug records are maintained in a data processing system, the system shall
- have a workable (electronic) data retention system which can produce a separate audit trail of
- drug usage by the provider pharmacy and by each remote site for the preceding two years as
- specified in §291.34(e) of this title.
- 773 (B) Prescriptions. Prescription drug orders shall meet the requirements of §291.34(b) of this title.
- 774 (C) Patient medication records. Patient medication records shall be created and maintained at the
- provider pharmacy in the manner required by §291.34(c) of this title.
- 776 (D) Inventory.
- 777 (i) A provider pharmacy shall:
- 778 (I) keep a record of all drugs ordered and dispensed by [sent to and returned from] a remote site
- separate from the records of the provider pharmacy and from any other remote site's records;
- 780 (II) keep a perpetual inventory of all controlled substances [and other drugs required to be
- 781 inventoried under §291.17 of this title,] that are received and dispensed or distributed from each
- remote site. The perpetual inventory shall be reconciled, by a pharmacist employed by the
- provider pharmacy, at least monthly.
- 784 (ii) As specified in §291.17 of this title. A provider pharmacy shall conduct an inventory at each
- remote site. The following is applicable to this inventory.
- 786 (I) The inventory of each remote site and the provider pharmacy shall be taken on the same day.
- 787 (II) The inventory of each remote site shall be included with, but listed separately from, the drugs
- of other remote sites and separately from the drugs at the provider pharmacy.
