



## Texas State Board of Pharmacy Pharmacist Certification Update

The Texas State Board of Pharmacy (TSBP) shall recognize as certified, any pharmacist who successfully completes a recognized certification program from an approved program as listed in [Board Rule §295.12](#). A pharmacist may not identify themselves as certified unless they have completed one of the programs specified in the rule. It is important to note that TSBP itself does not “board certify” individuals.

**NOTE:** Do not send certification documentation with this form.
