# **ADOPTED RULES**

#### **CHAPTER 281. ADMINISTRATIVE PRACTICE AND PROCEDURES**

#### SUBCHAPTER C. DISCIPLINARY GUIDELINES

## §281.63

The Texas State Board of Pharmacy adopted amendments to §281.63, concerning Considerations for Criminal Offenses. The amendments update the board's disciplinary guidelines concerning the imprisonment of a licensee, a registrant, or an owner of a pharmacy following a felony conviction or deferred adjudication, in accordance with Senate Bill 1080 and clarify certain provisions to align more closely to existing statute.

#### **CHAPTER 283. LICENSING REQUIREMENTS FOR PHARMACISTS**

#### §283.12

The Texas State Board of Pharmacy adopted amendments to §283.12, concerning Licenses for Military Service Members, Military Veterans, and Military Spouses. The amendments update the alternative licensing procedures, expedited licensing procedures, and interim license procedures for a military service member, military veteran, or military spouse, in accordance with House Bill 5629, establish provisional license procedures for a military service member, military veteran, or military spouse, in accordance with Senate Bill 1818, and make grammatical corrections.

#### CHAPTER 297. PHARMACY TECHNICIANS AND PHARMACY TECHNICIAN TRAINEES

#### §297.8

The Texas State Board of Pharmacy proposes amendments to §297.8, concerning Continuing Education Requirements. The amendments, if adopted, establish an electronic continuing education tracking system in accordance with Senate Bill 912, update continuing education programs in preparation for the statutory continuing education tracking system, specify that record retention requirements apply to all required courses, and make grammatical corrections.
